



## **Instruction for submission of Final version of conference paper and submission of IEEE copyright and consent form**

**Important notice:** Your completed **Final full paper** in PDF format (using only IEEE PDF eXpress; after review proces / notification of acceptance of your paper) must be uploaded to the conference website only by **May 15<sup>th</sup> 2025** at the latest. (It is important to note that submitting a file to IEEE PDF eXpress is only for creation of a compliant PDF file, you must still submit your Final paper through conference online submission).

### **Basic information:**

- Conference EPE 2025 has been registered for use of IEEE PDF eXpress (<https://ieee-pdf-express.org>)
- IEEE PDF eXpress is a free service to IEEE conferences, allowing their authors to make IEEE Xplore-compatible PDFs (Conversion function) or to check PDFs that authors have made themselves for IEEE Xplore compatibility (PDF Check function).
- The conference proceedings is indexed in Interactive Electronic Library (IEL) as a part of IEEE Xplore.
- All conference papers submitted for indexing in IEEE Xplore have to follow given requirements and IEEE Xplore compatibility verified with application IEEE PDF eXpress.
- The paper has to be prepared according to the Template (<http://www.epe-conference.eu/index2.php?section=authors&lang=en>).

- The organizing committee of the conference / IEEE stipulates the right to discard the non-presented paper from distribution. The discarded papers will be archived in IEEE, but they will not be indexed, nor presented in IEEE Xplore.

**Important notice:** The Final paper must be also resubmitted (uploaded to the conference website) by those authors, whose papers passed the review process and are marked as "*Accept in its current form*".

**Without next steps your paper will not be included at IEEE Xplore!**

## **1. Instructions for elaboration of the Final paper**

(Instructions for authors of accepted papers)

**Step 1:** The bottom of the first (first only!) page of your paper has to include “copyright notice” according to the following instructions (see the figure below):

- For papers in which all authors **are employed** by the US government, the copyright notice is:  
**U.S. Government work not protected by U.S. copyright**
- For papers in which all authors **are employed** by a Crown government (UK, Canada, and Australia), the copyright notice is:  
**979-8-3315-8636-2/25/\$31.00 ©2025 Crown**
- For papers in which all authors **are employed** by the European Union, the copyright notice is:  
**979-8-3315-8636-2/25/\$31.00 ©2025 European Union**
- For all other papers the copyright notice is:  
**979-8-3315-8636-2/25/\$31.00 ©2025 IEEE**

**Step 2:** Proofread your source document (paper) thoroughly to confirm that it will require no revision (It is highly recommended that you do this before going to IEEE PDF eXpress). **Please check reviews and editor comments for your paper!**

**Step 3:** Convert your paper from your source application format to Xplore-compatible PDF using IEEE PDF eXpress - see following procedure:

- Log in to the IEEE PDF eXpress site (see the figures below) <https://ieeepdfexpress.org>

First-time users should do the following:

1. Select the “**Create account**” link.

2. Enter the following:

- **67256X** for the Conference ID
- your email address
- a password

3. Continue to enter information as prompted.

An Online confirmation will be displayed and an email confirmation will be sent verifying your account setup.

**Previous users** of IEEE PDF eXpress need to follow the above steps, but should enter the same password that was used for previous conferences. Verify that your contact information is valid.

**Returning users:** Enter "**67256X**" for the Conference ID, email address and password.

4. Click on the "+*CREATE NEW TITLE*" button for each conference paper.

5. Enter identifying text for the paper (Paper title).

6. Drag and drop or Browse file to upload, and Click on the "*CONTINUE*".

7. You will receive online and email confirmation of successful upload.

8. You will receive an email with your Checked PDF or IEEE PDF eXpress-converted PDF attached. If you submitted a PDF for Checking, the email will show if your file passed or failed.

**Do not change the filename generated by IEEE PDF eXpress system!**

9. Submit / upload your converted PDF paper to EPE 2025 website (Administration area – Paper submission) - **See Step 4 below.**

## 2. Instructions for elaboration of the IEEE copyright and consent form

- The organizers of EPE 2025 commit to respect the publishing policy of IEEE.
- IEEE publishing policy requires that prior to publication all authors must transfer to the IEEE in writing any copyright they hold for their individual papers.
- Your electronic copyright transfer form should be submitted (signed) together with submitting of each Final full conference paper.
- Electronic version of Copyright Form (eCF) can be submitted to IEEE with the paper only if you received the confirmation of signed eCF.
- **Click on the button “Create IEEE copyright” in the section “Paper submission”** (see the figure below: step 2; **This button will only be visible after the notification of acceptance of your paper - i.e. after March 25<sup>th</sup> 2025**) **and follow the instructions of the electronic IEEE Copyright Form (eCF).**

- Confirmation of signed eCF and copy of eCF will be delivered to your email address. You should save a copy of eCF and **submit it together with the Final version of your paper** in the section “Paper submission” of the EPE 2025 conference interface (see the figures below).
- Repeat the process with all your papers.
